II. RESEARCH AIMS AND OBJECTIVES¹

What are the aims and objectives of the research?

The research question for this study is:

How acceptable is the Aptus device as a technology for providing access to e-resources?

What are user perceptions on the usefulness and ease of use of the Aptus device within the context of education in Samoa?

Hence the goals of this research were to explore the acceptance of using the Aptus to access e-resources within the context of education in

Samoa, with user acceptance measured by evaluating the ease of use and usefulness of the Aptus based on user perceptions.

Procedures

An aptus device was setup for each of the selected trial settings. In addition 60 sets of tablets and 10 mobile phones were distributed to participants within these selected scenarios/settings. Distribution was to ensure that each student/teacher has access to either a tablet or mobile phone:

a) NUS classroom

The aptus device was installed for use within two NUS classes. Due to the limits on the number of users to less than 20, classes selected are small classes such as two streams of Foundation Computer Studies (HCS081).

b) Primary School classroom

The aptus device was installed within three primary school classes, Years 6, 7 and 8 at Magiagi Primary school, and Moata'a Primary school. Due to the limits on the number of users to less than 20, classes selected are small classes of less than 20 students.

c) Secondary School classroom

The aptus device was installed within three secondary school classes Years 9, 10 and 11 at Samoa College, and Leififi College. Due to the limits on the number of users to less than 20, classes selected are small class size less than 20 students.

Once distributed, staff and students were trained in the use of the aptus device by members of the research team over a period of 3 days. Training involved the following activities:

For teachers:

- i) Setting up of the aptus device
- ii) Recharging the router

For teachers and students:

- i) How to navigate the aptus Home page
- ii) Downloading notes from the aptus
- iii) Uploading documents to the aptus
- iv) Using the Moodle virtual classroom
- v) Using the content management system

During training, teachers also discussed with the research team what activities were planned for the 4 weeks of the trial based on the 4 activities listed below. These activities formed their teaching plan for the 4 weeks of the trial. Upon completion of training staff and students were expected to trial the aptus for the following activities:

- i) Downloading notes from the aptus
- ii) Uploading documents to the aptus
- iii) Using the Moodle virtual classroom on the aptus
- iv) Using the content management system on the aptus

The trials were carried out in stages. This was to ensure that a sufficient number of tablets/mobile phones are available for each trial. The trial was carried out initially at NUS before implementing the trials in the schools. A helpdesk line was setup and manned by the research team for trouble shooting and answering any queries during the trial period. The research team also carried out a monitoring visit 2 weeks into the trial. Upon completion of the activities, staff and students were asked to complete the survey evaluating user perceptions on ease of use and usefulness of the aptus device. The questionnaire which has both English and Samoan versions were administered by the research team with the assistance of the teachers in the selected settings. For primary schools, the research team were assisted by interviewing the students and recording the responses for them.

b. Did your research progress as planned? Why or why not?

How did you manage the research going forward?

Yes the research went as planned except for the following:

i) Aptus Training had to be expanded to 2 separate sessions instead of the one training session scheduled for Primary and secondary schools. Secondary schools namely Samoa College were not available for the initial training.




